ministers yet, the American consuls and ministers take care of Filinino citizens. (a) Trade agencies established in America, Paris and

Shanghai also have taken care of Philippine business interests in those places. 3. Why do we have a Resident Commissioner?

(a) We have a Resident Commissioner to take care of the interests of our country in America, partieularly in Congress.

(b) He can speak in Congress on questions affecting the Philippines, but he has no vote,

4. Why do we have an Inspector-General of Labor? (a) Because we need one who can investigate labor conditions in various places where the interests or laborers make such investigations or inspections

meeessary. 1. He has the duty to learn the facts particular, ly in case of labor troubles, and to find solu-

tions to the recurrent problems of capital and labor 2. He can also moliate in such cases, to avoid

strikes which harm both labor and capital, ineluding the consuming public.

(a) To the American consul in the various cities, who will give him visaes or passes, or secure same for him.
